Dear Environmental Assessment Practitioners,

This newsletter addresses two issues (i) the DEA-EAPAN workshop held on 30 May 2013 and follow-up communications with the Environmental Commissioner, and (ii) our 2<sup>nd</sup> EAPAN AGM and miniconference on 18<sup>th</sup> October 2013.

## (i) Follow-up to our DEA-EAPAN workshop

I would like to start by thanking all the EAPAN members who attended our joint DEA-EAPAN workshop on 30 May to review the Environmental Management Act Regulations and their implementation. It was a hugely successful, open and constructive meeting with over 100 participants. We have had follow-up correspondence with the Environmental Commissioner. Two main issues have emerged:

- The DEA will work with EAPAN as it revises the legislation, and
- The Environmental Commissioner would like to see EAPAN be pro-active in moving the Association towards an Environmental Practitioners Council underpinned by legislation. We would like to discuss this at the AGM. A draft Environmental Practitioners Bill will be circulated to all members ahead of the AGM and this item will be placed on the Agenda.

# (ii) 2<sup>nd</sup> AGM and Annual mini Conference

The second AGM will be held at the Polytechnic Hotel and Tourism School on Friday 18<sup>th</sup> October 2013, starting at 10h00. The AGM will run until lunch at about 12h30. We are awaiting confirmation from the DEA in terms of their input to the meeting and this will be incorporated into an updated Agenda which will be distributed nearer to the event.
